**Santa Maria Regional Landfill  
SOLID WASTE FACILITY Permit Revision Application**

**BACKGROUND:**

On June 8, 2018, Santa Barbara County Public Health Department, Environmental Health Services Division, the Local Enforcement Agency (LEA) for the California Department of Resources Recycling and Recovery, received an application for permit revision regarding the Santa Maria Regional Landfill (Solid Waste Information System No. 42-AA-0016).

The application for solid waste facility permit (SWFP) requested a SWFP revision to allow an increase in final height from 362.5 to 410 feet MSL, while keeping the same total airspace capacity, an increase the estimated closure year to 2027, to increase the hours of operation so that the facility start time will be 5:00 am, to propose an alternative final cover option within the lined area, to update the groundwater monitoring and landfill gas control systems, to update figures and tables, to update the Non-Water Release Corrective Action Plan (NWRCAP), to propose the use of agricultural plastic to supplement the non-hazardous hydrocarbon impacted soils foundation soil, and to update appendices as needed. The facility is located at 2065 East Main Street in Santa Maria.

**LOCAL ENFORCEMENT AGENCY DETERMINATION:** The LEA will host a public meeting that is scheduled to take place on August 6, 2018. The purpose of the meeting is to make public the preliminary determination of the action to be taken by the LEA on the permit application. The LEA has made a preliminary determination that the application package is complete and correct, and the LEA will proceed with the processing of the permit application for approval.

**HOW TO COMMENT:** A copy of the permit application is on file and is available for public inspection in the LEA office located at 225 Camino del Remedio in Santa Barbara.
