### Representatives Needed To Serve On Several Committees

The City of Santa Maria is accepting applications to serve on the All-America City Committee, the Board of Appeals, and the Central Coast Commission for Senior Citizens, Area Agency on Aging. The deadline to apply for the All-America City Committee vacancy is Friday, May 16, 2014. Applications for the Central Coast Commission for Senior Citizens, Area Agency on Aging and the Board of Appeals will be accepted until sufficient applications are received and the vacancies can be filled.

Unless a specific advisory body has a City residency requirement, it is the policy of the City Council to appoint, whenever possible, residents of the City to fill appointive positions on all City commissions, boards, and committees. Unless otherwise noted in the membership description, the Mayor shall appoint members to all official City commissions, and boards, and they shall be ratified by the City Council.

**All-America City Committee (two appointments will be made to fill unexpired terms ending January 2015).** This committee works to enhance, maintain, and evaluate the civic health and pride of the community through partnerships and creative approaches, ensuring collaboration with the public and private sector, in the true spirit of the All-America City Program. Members are nominated by individual Councilmembers, appointed by the Mayor, and confirmed by the City Council. The appointment will be made by the City Council at the Tuesday, June 3, 2014 Council meeting.

**Board of Appeals (one appointment to serve an unspecified term).** The Board hears appeals to decisions of the City Building Official and makes recommendations regarding Uniform Building Code provisions. Seven members are appointed by the Mayor and confirmed by the City Council, including two special purpose members. Special purpose members shall be physically handicapped as defined in Section 2.4117(I), Title 24, Part 2 of the California Administrative Code. The appointee should be a licensed contractor, or be able to show extensive construction experience and training to qualify for appointment. Members may not be employees of the City of Santa Maria.

**Central Coast Commission for Senior Citizens, Area Agency on Aging (one nomination will be made to fill an unexpired two-year term ending in January 2015).**

The Board of Directors is responsible for the operations, including policy setting, allocations, and personnel for the Central Coast such as Area Agency on Aging, HICAP, and Senior Employment. This Board serves Santa Barbara and San Luis Obispo Counties. The Board meets monthly and its Board of Directors is elected by the Agency itself. The City Council nominates one member. Each member may serve no more than four consecutive terms.
